14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶ Targa Resources Corp. paid quarterly cash distributions on May 14, 2018 and May 15, 2018 to preferred and common shareholders respectively for the 1st Quarter 2018. At this time, based on reasonable assumptions, Targa Resources Corp. expects: 1) 0% of the annual cash distribution to preferred shareholders to be a non-taxable return of capital and, 2) 92% of the annual cash distribution to common shareholders to be a non-taxable return of capital.

Pursuant to the applicable Treasury Regulations under Section 6045B, if this assumption turns out to be incorrect, Targa Resources Corp. will file a corrected form 8937 within 45 days of such determination.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶ Targa Resources Corp. paid a cash distribution of \$23.75 per TRC Series A preferred share on May 14, 2018. Also, Targa Resources Corp. paid a cash distribution of \$.91 per common share on May 15, 2018. At this time, based on reasonable assumptions, Targa Resources Corp. expects: 1) 0% of the annual cash distribution to preferred shareholders to be a non-taxable return of capital to the extent of a preferred shareholder's tax basis in each Series A preferred share and, 2) 92% of the annual cash distribution to common shareholders to be a non-taxable return of capital to the extent of a common shareholder's tax basis in each common share. Any cash distribution exceeding a shareholder's tax basis in preferred or common shares is taxable as capital gain.


